Gillian Triggs, UNHCR Assistant High Commissioner for Protection, Cochair of Reference Group

Gillian Triggs is UNHCR's Assistant High Commissioner for Protection. She was appointed on 9 August 2019. Triggs is a highly renowned expert in international law who has held a number of eminent appointments in service to human rights and the refugee cause, including most recently as the President of the Australian Human Rights Commission and the Vice-Chancellor's Fellow and Emeritus Professor at the University of Melbourne.

Triggs oversees UNHCR's protection work for millions of refugees, internally displaced, stateless and other people of concern. An Australian national, she has previously held a number of leadership roles, including as President of the Asian Development Bank Administrative Tribunal, Chair of the UN Independent Expert Panel of Inquiry into Abuse of Office and Harassment in UNAIDS, Dean of the Faculty of Law and Challis Professor of International Law at the University of Sydney and as Director of the British Institute of International and Comparative Law in London. Triggs has been closely associated with a number of not-for-profit organizations throughout her career, including most recently as Chair of Justice Connect, an organization that connects 10,000 lawyers to provide pro bono advice to asylum-seekers and others in need of legal support in Australia. She is also the author of many books and papers on public international law. In July 2021 Gillian was awarded a Ruth Bader Ginsberg Inaugural Medal of Honour in recognition of her fight for the rule of law and gender equality.



Susanna Moorehead, Chair of the OECD's Development Assistance Committee (DAC), Co-chair of Reference Group

Susanna Moorehead was the British Ambassador to Ethiopia and Djibouti and UK Permanent Representative to the African Union and the United Nations Economic Commission for Africa. Over a 30 year career in international diplomacy and development, Moorehead has held senior executive, strategic, policy and operational roles - from the Board of the World Bank to famine relief in rural Africa. Moorehead served as the UK's Executive Director on the Board of the World Bank; was Director of West and Southern Africa at the UK Department for International Development (DFID);

and Head of DFID India, when it was the UK's largest development programme. She directed field-based famine and rehabilitation programmes in rural Mali for Save the Children and was Deputy Director of the Institute of Development Studies, Sussex until 1997. Moorehead has a BA from the University of York, an MSc (Econ) and PhD from the London School of Economics, as well as an honorary doctorate from the University of York.

Kareen Jabre, Director of the Division of Programmes, Inter-Parliamentary Union

Kareen in her role as Director is responsible for directing the organisation's various programmes of support and policy guidance to parliaments. Claus Lindroos, Deputy Director General, Finnish Ministry for Foreign Affairs

Claus Lindroos is the deputy director general of the department for Africa and the Middle East in the Finnish Ministry for Foreign Affairs since October 2020. Between 2015 and 2020 he served as director for humanitarian assistance and policy. He is a career diplomat and has been working in the Finnish diplomatic service since 1997, mainly on issues related to Africa and the United Nations. He has served in Finnish diplomatic missions in Nairobi, Dublin and Brussels.



Jean-Christophe Dumont, Head of the International Migration Division, Directorate for Employment, Labour and Social Affairs, OECD

Jean-Christophe in his role as Head of the International Migration Division oversees the OECD's annual flagship publication on migration; International Migration Outlook and numerous publications on the economic impact of international migration, as well as on migration management and the labour market integration of immigrants and their children in OECD countries. He joined the OECD Secretariat in 2000 to work on international migration issues. He has also worked on migration and development issues and on the international mobility of health workers. He holds a PhD in development economics from the University Paris IX-Dauphine and was a research fellow at Laval University, Quebec, Canada.



Manisha Thomas, Geneva Representative, Women's Refugee Commission

Manisha Thomas has been working on humanitarian issues for over 20 years and has been a consultant working with a range of organisations since October 2016. She is the part-time Geneva Representative of the Women's Refugee Commission. Previous positions included Coordinator of the Emergency Appeals Alliance (EAA), Interim Director of the Association of International Development Agencies (AIDA) in Palestine, and the Head of Secretariat for the Solutions Alliance. She also worked in the Inter-Agency Standing Committee (ASC) secretariat and held various positions at the International Council of Voluntary Agencies (ICVA), including supporting NGO coordination in Sudan and Haiti. She has an M.A. in International Affairs, Development Studies from the Norman Paterson School of International Affairs (NPSIA), Carleton University in Ottawa, Canada.



Dr. Helen Durham, Director of International Law and Policy, International Committee of the Red Cross (ICRC)

Helen in her role as Director oversees a large global network of international lawyers, policy advisers, armed forces delegates, weapons specialists, sociologists, diplomats, researchers and academic experts who work towards the respect of international humanitarian law (IHL). She regularly represents ICRC at the UN Security Council and in bi-lateral engagements with Minister, senior government officials and military decision makers. In the last few years, she has led a range of IHL multilateral negotiations in Geneva. Admitted as a Barrister and Solicitor of the Supreme Court of Victoria and High Court of Australia, she has an Arts and law degree with honours (Melbourne University) and a PhD (Melbourne University with research at New York) in international law, with a focus on International Humanitarian Law (IHL) and international criminal law. Previously she has been a legal adviser for ICRC in the Pacific Region, Head of Office for ICRC in Australia and held a range of roles in Australian Red Cross.



Kathrine Starup, Head of Protection Unit - Global Protection Advisor, Danish Refugee Council (DRC)

Kathrine Starup has more than 25 years of experience with humanitarian and displacement work. Kathrine is specialised in Protection, including Community-Based Protection, Legal Aid, Solutions to refugee and IDP displacement, Protection Information Management and mixed migration. Kathrine has worked with the UN and international and local NGOs in the field and at headquarters and has field experience from Africa and Asia. Prior to joining DRC, she worked with UNHCR. Kathrine sits on the Executive Committee of Joint IDP Profiling Service (co-founded by DRC) and on the ICRC-led Advisory Group for the 'Professional Standards for Protection Work'. She is also the co-founder of the Protection Information Management - PIM Initiative (co-lead by DRC & UNHCR) and is long-time member of the International Advisory Board to the Forced Migration Review.



Anila Noor, Managing Director, New Women Connectors

Anila is a policy influencer for inclusion, diversity and social justice, feminist ecosystem builder, activist, TEDx Speaker and researcher based in the Netherlands. She recently became the member of European Commission Expert Group and evaluator for AMIF calls. As an advisor and expert consultant, she works with different institutions on designing engagement projects related to inclusion and diversity. She initiated New Women Connectors, a movement striving for mainstreaming the unheard voices of migrant and refugee women living across Europe. She is also the co-founder of European Coalition (GRN), Global Independent Refugee Women Leaders (GIRWL), part of Advisory of UNHCR Taskforce for PoCs, member of Kaldor Centre of Emerging Scholars Network Australia and core team member of steering committee of Global Refugee Led Network . Najeeba has been actively involved in the development of refugee-led networks at both the regional and global level, which focuses on bringing together refugee and migrant-led organizations and refugee change-makers from around the world to gather to discuss their lived experiences and propose solutions for more effective and sustainable refugee policy. She is an advocate, educator, public speaker, and researcher with strong qualitative and quantitative skills. She has worked throughout policy and program cycles from design, implementation, review and evaluation. Through all her work, she prioritises and amplifies the voices, experiences, and aspirations of those most directly impacted. She has been a gender audit to the United Nations High Commissioner for Refugees and ensuring Gender equality and the empowerment of refugee and migrant women remains a top priority commitment .



Barthelemy Mwanza, Co-Chair of the UNHCR Global Youth Advisory Council

Barthelemy is the co-chair and delegate of the UNHCR Global Youth Advisory Council (GYAC) where he represents the voice of youth at various UNHCR events such as the High Commissioner Dialogue and annual UNHCR Annual Consultations with NGOs. He works as a Protection Monitor with the UNHCR Harare community where he amplifies the refugee voices and connect them to relevant stakeholders to help refugees report issues related to protection and development. A journalism student by profession, he is multilingual and is proficient in four languages: English, French, Swahili and Lingala. As GYAC delegate, he took a wide range of responsibilities including engaging in consultations with communities; advocating with States; identifying good practices; networking; and programming, for instance by identifying and supporting projects and programs. In addition to GYAC, he has been also involved in Community-based Child Care Worker for *Terre des Hommes*, which is an international company promoting education, fighting against Sexual Gender Based Violence and child abuse and providing psycho-social support.



Dany Bahar, Senior Fellow, Global Economy and Development, Brookings Institution

An Israeli and Venezuelan economist, Danny was previously a David M. Rubenstein Fellow at Brookings is also an associate at the Harvard Center for International Development, and a research affiliate both at CESifo Group Munich and IZA Institute of Labor Economics. His research sits at the intersection of international economics and economic development. In particular, his academic research focuses on the diffusion of technology and knowledge within and across borders, as measured by productivity, structural transformation, exports, entrepreneurship and innovation, among other factors. His research has focused on migrants and refugees as drivers of this process, alongside trade and capital flows.



Bilal Siddiqi, Director of Research at the University of California, Berkeley's Center for Effective Global Action

Bilal is an economist who studies poverty, institutions, and conflict in low- and middle-income countries, using applied microeconometrics and experimental methods to understand the causal impacts of policy interventions. He has worked primarily in Sierra Leone, Liberia, Pakistan, India, Kenya, Tanzania, Croatia, and the Philippines. Prior to UC Berkeley, Dr. Siddiqi spent five years as an Economist at the World Bank, where he worked with governments to embed impact evaluation into their operations and oversaw global research programs on justice reform and digital ID systems. His research has been published in the Quarterly Journal of Economics, Science, Lancet, and others, and covered by the New York Times, the Washington Post, NPR, CBS, New York Magazine, Voice of America, Le Monde, the Hindustan Times, and several other outlets. Dr Siddiqi has been a Minerva Postdoctoral Fellow at Stanford University and an AMID Scholar at the Institute for International Economic Studies at Stockholm. He holds a Ph.D. in Economics from Oxford University, where he studied as a Rhodes Scholar.



Jane McAdam, Scientia Professor of Law, Director of the Kaldor Centre for International Refugee Law, UNSW Sydney

Jane is a Fellow of the Academy of the Social Sciences in Australia and a Fellow of the Australian Academy of Law. She is also a Research Associate at Oxford University's Refugee Studies Centre, an Associated Senior Fellow at the Fridtjof Nansen Institute in Norway, and a Senior Research Associate of the Refugee Law Initiative in London, and was previously a non-resident Senior Fellow in Foreign Policy at The Brookings Institution in Washington DC (2012–16) and a Visiting Professor at Harvard Law School (2019). Jane publishes widely in international refugee law and forced migration, with a particular focus on displacement in the context of climate change and disasters. Some of her books include Climate Change, Forced Migration, and International Law (Oxford University Press, 2012). In 2017, she was awarded the prestigious international Calouste Gulbenkian Prize for Human Rights for her work on refugees and forced migration, becoming the first Australian recipient of the award

As the MMC's Executive Director, Vittoria Zanuso oversees the organization's efforts to help cities influence international deliberations and ensure that migration and refugee policy both reflects and helps cities address realities on the ground. In her role, Ms. Zanuso sits on the Steering Committees of the U.N. Start-Up Fund for Safe, Orderly and Regular Migration (Migration MPTF) and the Mayors Mechanism of the Global Forum on Migration and Development, and serves on the Advisory Committee of the Platform for Disaster Displacement. Prior to joining the MMC, Ms. Zanuso held multiple positions at the Rockefeller Foundation's 100 Resilient Cities initiative (100RC), liaising with mayors, senior officials and private sector leaders to address natural and human-made disasters, from climate change to rising global inequality. Ms. Zanuso began her career in the field of strategic communications, first at the Spokesperson's Office of the Vice-President of the European Commission in Brussels and then on the Communications team of the Clinton Global Initiative in New York City. Originally from Milan, Italy, Ms. Zanuso holds an MPA in International Policy and Management from NYU's Robert F. Wagner Graduate School of Public Service and a BA in Politics from Queen Mary University of London.



Dr. Santino Severoni, Director of the Global Health and Migration Programme, WHO

Dr. Severoni since 2000 has held senior positions at the World Health Organization European Office. He is a medical doctor, health economist, epidemiologist, and experienced system management.
